Resident asked if the rumor that the Sheridan Drive Association wanted to petition to abandon Sheridan Drive was correct? Concerned with privatization of lake through these types of processes. The Board confirmed that the RCRC had approached Sheridan Drive Association about possible abandonment but no petition had been sent as of yet. Closed at 8:06pm.
