### ***Gerrish Township Police Monthly Report 01-01-17 through 01-31-17***

The Gerrish Township Police Department responded to a total of 109 calls for service for the month of January 2017.

The Department reports 6 various custodial arrest statistics this month. (See attached report for breakdown).

The Department reports 26 total citations listing 25 traffic violations, 13 written verbal warnings, and 5 misdemeanor citation statistics for the month. (See attached for breakdown).

#### **Training:**

The department reports 1.2 credit hours of training this month. (See attached detail document).

Chief Hill highlighted activity for the reported month is as follows:

- 1) I chaired the Roscommon County 911 Technical Board meeting and additionally was elected as chairperson again for the 2017 calendar year.
- 2) I attended the regular Township Board work session meeting as required.
- 3) I attended the monthly ACT-NOW Executive Board meeting in my advisory role.
- 4) I attended the Roscommon County LEPT meeting.
- 5) I attended the joint Task Force meeting at MSP # 72 Post to plan for future Search Warrants and further investigative path to bring an end to a long string of break-ins in the County.
- 6) I attended the monthly Roscommon County Law Enforcement Administrators meeting held at Fred's Restaurant in Roscommon, Mi.
- 7) I met with Sgt Patchin and Administrative Clerk Julie Hill for the purposes facilitating a framework for Operational and Organizational planning goals for the Police Department for the coming 2 years.
- 8) I held a staff meeting to discuss and strategic plan for the coming year to establish goals and financial planning for ACT-NOW in support of its mission.
- 9) I hosted a final planning session for the CERT final on Jan. 24, 2017 with the planning team.
- 10) I attended the monthly Northern Michigan Children's Assessment team meeting to discuss active investigations.

- 11) I attended the Sobriety Court graduation of a Township resident at his request as same had completed a 2 year long process in his sobriety journey. It has been a long journey for this individual but I have supported him along the way for him to find a new path in life.
- 12) I met with Dale Boehm from AUL to discuss Insurance costs and predications for cost increases and to further discuss other options if affordable.
- 13) Sgt Patchin, Administrative Clerk Julie Hill and I participated in a webinar with the PowerDMS company who has a product to assist with the Accreditation process should we continue to find it beneficial for our future.
- 14) I attended the Roscommon County Community Corrections Authority Board as a member of that board to further discuss and select treatment programs available and administration of the grant for the program for the Roscommon County Jail and Courts.

As some further notes this month;

We have added 5 new CERT Members to our talented team of volunteers and dedicated citizens of Gerrish Township this month. A big thank you to the staff/instructors and the class members on a job well done.

I am happy to report that we have been full staff for over a year now. This has not been the case for many years. We are now in a schedule design model to offer us the best possible coverage that assists in the work load for all.


The coming months will be filled with planning our goals for the next two years which may include State of Michigan Accreditation as an agency.
